**WHO:** Authorized by Congress, NCMEC's CyberTipline is operated in partnership with the Federal Bureau of Investigation (FBI), the Department of Homeland Security's Immigration and Customs Enforcement (ICE), the U.S. Postal Inspection Service (USPIS), the Internet Crimes Against Children Task Forces (ICACs), the U.S. Secret Service (USSS), the U.S. Department of Justice's Child Exploitation and Obscenity Section (CEOS), as well as other international, state, and local law enforcement.

**WHAT:** Launched in March of 1998, the CyberTipline offers a means of reporting incidents of child sexual exploitation including the possession, manufacture, and/or distribution of child pornography; online enticement; child prostitution; child sex tourism; extrafamilial child sexual molestation; unsolicited obscene material sent to a child; and misleading domain names, words, or digital images. The CyberTipline is staffed 24 hours a day, 7 days a week.

**GOALS:** To empower the public to take immediate and direct action to enforce a zero tolerance policy regarding child sexual exploitation. To assist all levels of law enforcement by providing one streamlined reporting tool that enhances information sharing and collaborative efforts to combat these crimes.

**LAWS:** Federal law (18 U.S.C. §2258A) requires Electronic Service Providers (ESPs) to: (1) register with the CyberTipline; and (2) report apparent child pornography directly to the CyberTipline.

**FUNDING:** The CyberTipline is supported by the federal government and corporate donors.

**HOW:** Any incidents reported to the CyberTipline online or by telephone go through this three-step process.

- CyberTipline operators review and prioritize each lead.
- NCMEC's Exploited Children Division analyzes tips and conducts additional research.
- The information is accessible to the FBI, ICE, and the USPIS via a secure Web connection. Information is also forwarded to the ICACs and pertinent international, state, and local authorities and, when appropriate, to the ESP.
